SECTION 1 EDITORIAL

XBRL makes Near Real-time Reporting Possible

Corporate actions, such as dividend declarations, stock splits, mergers and other activities that directly affect shareholders are closely watched and used by some key market participants for advanced trading purposes. Traditionally they have been made available to dealers and investors through the old manual routine - press releases and regulatory filings – routines that are not machine readable. Consequently they need to be re-input into transactional systems, which is time consuming and expensive.

The market moves very quickly now and there is a continuing demand for it to move even faster. The problem is that regulators and others need to try and maintain a level playing field for all investors. With the speed of electronic news, even a few seconds advance notice of a significant event can be enough to create an advantage for some traders. So the need for a technology solution to eliminate these unfair advantages is growing more crucial.

XBRL enables seamless and automatic transmission of data in a form that can be automatically acted upon without the need for human intervention. Since it moves at electronic speed, corporate actions can be transmitted instantaneously. Unfair time differences in reporting can be eliminated.

XBRL Canada, XBRL US, XBRL International and others are working on this opportunity to improve the investment environment. A Corporate Actions taxonomy has been developed and one is being adapted to Canadian purposes. Stay tuned!

SECTION 2

New Canadian Taxonomies in Process

XBRL Canada has launched into a process of developing two new taxonomies for use in Canada. One is for reporting Corporate Actions, as discussed in the preceding article, and the other for reporting data for Oil and Gas companies.

The corporate actions taxonomy comes out of recent growth in interest in using XBRL to report quickly. It is hoped that this taxonomy will be available in the new year.

The oil and gas taxonomy is a product of our dedicated Oil and Gas working group in Calgary. It works on a base of International Financial Reporting Standards (IFRS) but includes data from inside and outside the financial statements that is considered useful for analysis of oil and gas companies.
